**NO ONE SHALL BE ALLOWED TO REMAIN IN THE PARK IN EXCESS OF 180 CONSECUTIVE DAYS IN A CALENDAR YEAR.** THE UNDERSIGNED REQUESTS A LEASE TO PARK A RECREATIONAL VEHICLE ("RV") AND A TOW VEHICLE, IF APPLICABLE, AT ARLINGTON RENTALS, INC. D/B/A COACHES CORNER. SITES WILL BE ASSIGNED BY ARLINGTON RENTALS, INC. THE UNDERSIGNED AGREES TO USE AND TO REQUIRE UNDERSIGNED'S AGENTS, SERVANTS, EMPLOYEES, FAMILY, FRIENDS, GUESTS, AND INVITEES TO USE THE PROPERTY IN ACCORDANCE WITH THE RULES. 3. REFRIGERATORS CAN BE LEFT ON, AC'S SHOULD BE TURNED OFF OR THERMOSTATS SHOULD BE SET AT 85 DEGREES. THIS HELPS KEEP THE POWER COST DOWN WHICH HELPS KEEP RATES DOWN.
4. PLEASE, REMOVE ALL GRILLS, CHAIRS ETC FROM GRASS MOWING AREA & SECURE OR PUT INSIDE RV.
